

THE AARON'S GIFT-A-DAY- GIVEAWAY SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Aaron's Gift-A-Day Giveaway Sweepstakes ("Sweepstakes") is sponsored by Aaron's, LLC ("Sponsor"), 400 Galleria Parkway SE, Suite 300, Atlanta, GA 30339 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on December 1, 2021 at 12:00 PM Central Time ("CT") and ends on December 31, 2021 at 11:59:59 PM CT ("Sweepstakes Period"). The Sweepstakes Period includes a grand prize drawing ("Grand Prize Drawing") that runs the entire length of the Sweepstakes Period and includes thirty-one (31) daily entry periods (each a "Daily Entry Period"), one for each calendar day of the Sweepstakes. A "day" is defined as starting at 12:00 AM CT and ending at 11:59:59 PM CT on a calendar day during the Sweepstakes Period, except on December 1, 2021 when a day is defined as starting at 12:00 PM CT and ending at 11:59:59 PM CT. Non-winning Daily Entry Period entries do not carry forwarding into subsequent Daily Entry Period drawings. The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States, including the District of Columbia, but excluding Alaska, Hawaii, Minnesota, and Wisconsin, who are at least eighteen (18) years old (at least nineteen [19] years old in Alabama and Nebraska) at the time of entry. Employees, officers, directors, and representatives of Sponsor and Administrator, and each of their respective parent companies, subsidiaries, dealers, franchisees, franchisors, licensees, distributors, suppliers, participating retailers, affiliates, advertising and promotion agencies, persons engaged in the development, production, or distribution of materials for this Sweepstakes, (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, grandparents, child, sibling, grandchildren, and their respective spouses and the "steps" of each, whether biological, adopted, or in-law, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in Alaska, Hawaii, Minnesota, Wisconsin, and where prohibited or restricted by law.

Upon the successful submission of the registration information, an entrant will receive one (1) entry into the applicable Daily Entry Period and one (1) entry into the Grand Prize Drawing. Entrant will only get one (1) entry into the Grand Prize Drawing upon his/her first Daily Entry.

Entry Limit: There is a limit of one (1) entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Bonus Entry Limit: Regardless of the method of entry, there is a limit of two (2) bonus entries into the Grand Prize Drawing per person during the entire Sweepstakes Period, one (1) via marketing e-mail opt-in and one (1) via either SMS message opt-in or Mail-In Entry. 4. RANDOM DRAWING: On or around January 11, 2022, the Administrator will randomly select one (1) potential grand prize winner from all eligible entries received in the Grand Prize Drawing. On or around each calendar business day following each Daily Entry Period, the Administrator will randomly select one (1) potential Daily Entry Period prize winner, for a total of thirty-one (31) potential Daily Entry Period prize winners. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Grand Prize (1): The grand prize includes a 65” Class 4K UHD Smart TV, 32OW 2.1CH Sound Bar Bundle, and a two (2) piece Envy Chaise Sofa and Ottoman (“Grand Prize”). No more than one (1) Grand Prize will be available in the Sweepstakes. The ARV of the Grand Prize is \$2,253.96.

C. Total ARV: The total ARV of all prizes is \$34,813.13.

D. Odds of Winning: The odds of winning the Grand Prize depend on the number of eligible Sweepstakes entries received in the Grand Prize Drawing during the Sweepstakes Period

and the odds of receiving a Daily Entry Period Prize depend on the number of eligible Sweepstakes entries received in each Daily Entry Period during the Sweepstakes Period.
